Beat/Instrumental Exclusive License – Terms & Conditions

By purchasing an exclusive license for any beat/instrumental through Gary Gretarsson INC, you automatically agree to the following terms and conditions:

1. Gary Gretarsson (the Licensor) owns the recording that you have received, including its musical composition. You (the Licensee) have paid for the right to use it, and the right to be the only person (Human, Corporation, or otherwise) given that right by Gary Gretarsson (Unless you consent to such actions), during the term of this agreement.
2. You, the artist, may record vocal synchronization over the track, and those vocals are yours to keep. The track (instrumental/beat recording/composition) itself remains the property of Gary Gretarsson.
3. This license agreement is non-transferable, meaning you may not give or sell it to anyone else, including, but not limited to, family and friends.
4. You (the Licensee) shall acknowledge the original authorship of the Composition appropriately and reasonably in all media and performance formats under the name "Gary Gretarsson" in writing where possible and vocally otherwise.
5. Third party sample clearance is the responsibility of the licensee.
6. The term of this agreement executed by the Licensor and the Licensee, is to be effective for all purposes as of the date of initial purchase and shall terminate exactly **twelve (12)** years from that date, and must be re-negotiated at that time.
7. All monetization and income resulting from the Composition, Recording, and Resulting song, (Physical, streaming, broadcast, YouTube or otherwise), during the term of this agreement, are to be split at the rate specified at the bottom of this agreement under "Royalties"
8. Gary Gretarsson and Gary Gretarsson INC must be included in all negotiations for the release of the Composition, Recording, and Resulting song through a Label, (Major or otherwise), at which time this agreement may be re-negotiated. Gary Gretarsson and Gary Gretarsson INC reserve the right to refuse what they may deem a "Bad Deal", and retain their rights.
9. Your rights are as follows:

-EXCLUSIVE LICENSE-

Mechanical Rights. Gary Gretarsson hereby grants to Licensee (You) an exclusive license to use Master Recording in the reproduction, duplication, manufacture, and distribution of phonograph records, cassette tapes, compact disk, digital downloads, other miscellaneous audio and digital recordings, and any lifts and versions thereof (collectively, the "Recordings", and individually, a "Recording") worldwide for the pressing or selling of **UNLIMITED** copies of such Recordings or any combination of such Recordings. Additionally licensee shall be permitted to distribute Unlimited free Internet downloads or streams for **non-profit** and **non-commercial** use. This license allows **UNLIMITED** monetized audio streams on streaming services and sites like, but not limited to, Spotify, RDIO, Rhapsody, Napster, Amazon Music, Google Play Music, Tidal, Deezer, and Apple Music (calculated as the sum of all total sites and services). **It is also** eligible for monetization on YouTube.

Synchronization Rights. Gary Gretarsson hereby grants limited synchronization rights for **UNLIMITED** music videos streamed online (Youtube, Vimeo, or otherwise) for unlimited **monetized** video streams on all total sites. Distribution to film, television or video games is allowed and encouraged.

Performance Rights. The Licensor (Gary Gretarsson) here by grants to Licensee (You) a non-exclusive license to use the Master Recording in Unlimited **non-profit** performances, shows, or concerts. Licensee **may also** receive compensation, monetary or otherwise, from performances with this license.

Royalties. All Royalties for the Sale, Distribution, Broadcast, or The Performance of any kind, in any derivative, of the Composition and the resulting Vocal Synchronization, shall be allocated as follows:

Writing Shares: 50%- Gary Gretarsson - ASCAP
50%- Licensee (You) – Your PRO

Publisher Shares: 50%- Gary Gretarsson INC-
ASCAP
50%- Licensee (You)- Your PRO
