## Beat/Instrumental Standard License – Terms & Conditions

By purchasing a license for any beat/instrumental through Gary Gretarsson INC, you automatically agree to the following terms and conditions:

- 1. Gary Gretarsson (the Licensor) owns the recording that you have received, including its musical composition. You (the Licensee) have paid for the right to use it.
- 2. Gary Gretarsson retains the right to provide these rights to others as he sees fit.
- 3. You, the artist, may record vocal synchronization over the track, and those vocals are yours to keep. The track (instrumental/beat recording/composition) itself remains the property of Gary Gretarsson.
- 4. This license agreement is non-transferable, meaning you may not give or sell it to anyone else, including, but not limited to, family and friends.
- 5. You (the Licensee) shall acknowledge the original authorship of the Composition appropriately and reasonably in all media and performance formats under the name "Gary Gretarsson" in writing where possible and vocally otherwise.
- 6. Third party sample clearance is the responsibility of the licensee.
- 7. Publishing rights are 100% owned and controlled by Gary Gretarsson Inc.
- 8. The term of this agreement executed by the Licensor and the Licensee, is to be effective for all purposes as of the date of initial purchase and shall terminate exactly **seven** (7) years from that date.
- 9. Your rights are limited. Your allowances are as follows:

## -STANDARD LICENSE-

Mechanical Rights. Gary Gretarsson hereby grants to Licensee (You) a non-exclusive license to use Master Recording in the reproduction, duplication, manufacture, and distribution of phonograph records, cassette tapes, compact disk, digital downloads, other miscellaneous audio and digital recordings, and any lifts and versions thereof (collectively, the "Recordings", and individually, a "Recording") worldwide for up to the pressing or selling a total of **Two Thousand**, **Five Hundred (2,500)** copies of such Recordings or any combination of such Recordings. Additionally licensee shall be permitted

to distribute Unlimited free Internet downloads or streams for nonprofit and non- commercial use. This license allows up to Four Hundred Thousand (400,000) monetized audio streams on streaming services and sites like, but not limited to, Spotify, RDIO, Rhapsody, Napster, Amazon Music, Google Play Music, Tidal, Deezer, and Apple Music (calculated as the sum of all total sites and services). It is not however eligible for monetization on YouTube. Synchronization Rights. Gary Gretarsson hereby grants limited synchronization rights for One (1) music video streamed online (Youtube, Vimeo, etc.) for unlimited non-monetized video streams on all total sites. Distribution to film, television or video games is prohibited and must be negotiated with Gary Gretarsson directly. Performance Rights. The Licensor (Gary Gretarsson) here by grants to Licensee (You) a non-exclusive license to use the Master Recording in Unlimited **non-profit** performances, shows, or concerts. Licensee may not receive compensation, monetary or otherwise, from performances with this license.
